Workshop Description

Trustees, boards of directors of charities and associations are essential to the efficacy of their organisations. It is the role of these governing bodies to ensure that the organisation is administered effectively, can account for its activities and delivers on its promises. Governance is not necessarily about doing, it is about ensuring things are done.

It is vital a board or committee work as a team and invest in maintaining their capacity to work together, and with the staff and volunteer.

Delivering good governance is not straight forward and so this half-day course will:

- Provide information on charity law and good practice in governance
- Provide guidance on achieving clear roles and accountability
- Explore the key issues and dynamics for boards and their members
- Presents ideas and approaches for board self-assessment, training and development.

Workshop Outline

This short and fast moving workshop will drill down into a range of technical knowledge and soft skills needed by any board member or a trustee. We will look at:-

- Key definitions for (i) governance (ii) remit of board members and (iii) best practice set against the Nolan Standards in Public Life and the Carver Principles
- The law -a focus on compliance issues and the Charity Commission -the latest breaking news!
- Key risk areas and how to avoid the elephant traps -more legal issues around vicarious liability and the duty of care. Other statutes
- Skills audit and self assessment -what have we got?/what do we need? -individually and collectively
- Action Planning -what are going to after this event -a SMARTER action framework
- Signposts to other sources of good information and resources

William, the facilitator, is a self confessed "anorak" in equality laws, diversity issues and cultural awareness. As a former Tribunal and County Court officer with the Equal Opportunities Commission he has helped represent scores of discrimination cases in employment and service delivery. And when he is not working he is a volunteer advocate in Manchester representing people with cases of discrimination, bullying, harassment, victimisation as well as those pursuing employment, welfare benefit and immigration claims. He is also a Trustee himself!
