Workshop Description

The term 'Social Enterprise' is widely used to describe enterprising third sector organisations but what does it actually mean? To answer this reference will be made to the wide diversity of social enterprise organisations currently operating in and across the UK, the range of services and activities provided by these organisations and how social enterprise develop their income generation potential.

This one-day course will also introduce the range of legal structures currently available for the third sector and how these structures relate to social enterprises, including the traditional ones of company limited by Guarantee and Development Trusts and the never Community Interest Company (CIC). The course will also cover issues around charitable status, setting up a trading subsidiary, what is a Trustee, and roles and responsibilities for Directors. Where appropriate, references will be made about the social business reasons influencing such structural development.

The course is divided into 2 parts and participants can attend both or just the morning or afternoon session.
